



The City of San Antonio continues to grow in importance as one of the top 10 largest cities in the United States of America. Its population of 1,409,019 ranks San Antonio as the seventh most populated city in the country, and second in the state of Texas.

The City of San Antonio is the Tourism Capital of Texas. It attracts over 20 million tourists per year. In 2016, San Antonio was ranked as the #2 Best Travel Destination in the World by Budget Travel. The Economic Impact Study that the San Antonio Tourism Council conducts every two years reveals that tourism contributes more than \$10.7 billion to the local economy. The Henry B. Gonzalez Convention Center alone hosts more than 300 events each year, and over 750,000 convention delegates from around the world.

The #1 attraction in San Antonio is The Alamo, an old fortress that represents for Texans their independence from the Mexican army. The Alamo is considered as one of the UNESCO World Heritage Sites.

The City of San Antonio is also famous for its River Walk, the city's second most visited attraction. It runs from the Museum Reach area all the way to Downtown and provides access to stunning bike and walking paths. At the River Walk, guests can visit numerous distinguished shops, restaurants, and bars.
